3. <u>Payment</u>: Payments to the bidder, would be made as under:-

(a) **Payment Schedule**

(b) No advance payment will be made.

(c) The payment will be given after successful completion of the activity through treasury-transaction mode. The bill has to produce within 10 days after completion of the activity in duplicate in the name of Assistant Seed Testing Officer, Seed Testing Laboratory, Ranchi.

6. Execution of agreement

7. Force Majeure

- a) The supplier/ selected bidder shall not be liable for forfeiture of its PSD, LD, or termination for default if and to the extent that it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- b) For purposes of this Clause, "Force Majeure" means an event or situation beyond the control of the supplier/ selected bidder that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the supplier/ selected bidder. Such events may include, but not be limited to, acts of the Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.
- c) If a Force Majeure situation arises, the supplier/ selected bidder shall promptly notify the ASTO, STL. writing of such conditions and cause thereof within 15 days of occurrence of such event. Unless otherwise directed by ASTO, STL. the supplier/ selected bidder shall continue to perform its obligations under the contract as far as reasonably practical.
- d) If the performance in whole or part or any obligation under the contract is prevented or delayed by any reason of Force Majeure for a period exceeding 60 days, either party at its option may terminate the contract without any financial repercussion on either side.
